

CONSIGNOR AGREEMENT

This Consignment Agreement by and between FORYOU TRENDY WEAR IT AGAIN FASHIONS INC., hereinafter referred to as "FORYOU" and _____ (Print Name) of _____ (Print your City), hereinafter referred to as the "Consignor",

Therefore, the aforementioned Parties hereby agree as follows:

That FORYOU agrees with Consignor to take the Consignor's goods on consignment to attempt to sell such goods for the Consignor, and

That in consideration of the above named and the following promises and other good and valuable consideration as in hereinafter recited, the parties further agree as follows:

1. Consigned items must be in excellent condition and of high quality. All apparel presented for consignment must be odor free, cleaned in the last three weeks and ready for resale. FORYOU reserves the right to refuse items that are deemed to be unmarketable as determined by the sole discretion of FORYOU for reasons including, but not limited to designer, style, size, condition, marketability, inventory levels and past selling experience.
2. The term of consignment shall be a period of sixty (60) days commencing the date the consigned goods are delivered to FORYOU and specified on the consignment receipt claim issued to the Consignor at the time of delivery. If the Consignor desires to reclaim unsold goods, the Consignor must do so before the sixty (60) day term expires. All unclaimed and/or unsold goods become the sole property of FORYOU after sixty (60) days and shall be disposed of as FORYOU sees fit.
3. FORYOU determines the pricing of all consigned goods. However, most goods are to be sold at approximately 1/3 of the estimated new retail value. The Consignor shall received 40% of the final selling price, not including additional taxes paid, of any consigned goods. FORYOU reserves the right to reduce the original advertised price of the consigned goods by up to 25% after thirty (30) days and up to 50% after forty-five (45) days. Some consigned goods may be further reduced by up to 75% for the winter and summer clearance sales that FORYOU may hold occasionally.
4. All consigned goods will remain in the possession of FORYOU for the duration of the consignment period or until the goods are otherwise reclaimed by the Consignor.
5. The Consignor may pick up payment for consigned goods that have been sold at any time during the normal business hours of FORYOU. Cash payments owing to the Consignor may be received for amounts up to \$50.00. For amounts over \$50.⁰⁰, FORYOU shall issue a cheque to the Consignor.
6. FORYOU is not responsible for any fire, theft or water damage to any item. The Consignor agrees to waive any claim against FORYOU for any losses or damage caused to any consigned good by theft, fire, water damage or any other natural disaster. FORYOU shall take every reasonable precaution to assure that the Consignor's items are cared for in a safe and responsible manner during the consignment term.
7. FORYOU reserves the right to take photographs of any consigned good for the purposes of providing information to potential customers via email from the on-line FORYOU ?WISH LIST≤ service.

I, _____ (Print Name) have read and agree to the conditions and terms of this agreement. I understand that FORYOU shall not be held liable for any theft or damages to consigned goods that I may provide to FORYOU. I further understand that if I do not pick up consigned goods that I want returned prior to the expiration of the consignment period (being sixty days), they become the sole property of FORYOU and I shall not receive any compensation for said consigned goods.
